# PINTO POINT OWNERS ASSOCIATION FALL BOARD MEETING NOVEMBER 7, 2017

- **1. Meeting called to order** called to order at 6:50 pm. Members present were Denny Christenson, Bill Bates, Bryan Dearden, Jim McLean, Dave Tewel and Jan Tewel
- 2. Minutes from April 13, 2017 Minutes were approved as written
- 3. Old Business -

Fire District Expansion: Denny advised us of the status of the proposed fire district expansion and construction of the Indian Creek Fire Station. Since the Bonner County Tax Assessor is assessing the improvements well under their appraised values, the 221 lots would only supply \$30,000/year for the proposed new Fire Station. Coolin-Cavanaugh Fire District indicated that the operating funds required for the new station would be approximately \$60,000 to \$70,000/year. Coolin-Cavanaugh Fire District indicated that they cannot move forward with the fire district expansion without the required guaranteed annual funding. They are open to a contract for fire district coverage expansion or an annexation of the uncovered area, if the necessary funds could be guaranteed. We do not meet the requirements to be eligible to form our own Fire District. Since there is currently no way to guarantee continuous annual funding for the fire district expansion, there isn't a way to move forward at this time.

Denny also requested that someone from the Fire District Expansion Work Committee take over for him. He does not feel qualified to do what is necessary to obtain the required funding or to act as the Lead for the annexation legal requirements. Denny will call another Fire District Expansion Work Committee meeting to discuss this further.

**LPOA's:** Since we are not currently moving forward with the expansion of the fire district, there is no need to obtain the remaining LPOA's for members who purchase their lots.
